Thank you for your interest in the Momentive Performance Materials product LIM6071.

In response to your above-mentioned query, we would like to inform you that a representative sample of LIM6071 has been screened for USP Class VI testing requirements under Good Laboratory Practices (GLP):

The product sample met the requirements of the following tests:

- Systemic Injection Test
- Intracutaneous Toxicity Test
- Intramuscular Implantation Test
- Agar Diffusion
- MEM Elution
- Primary Skin Irritation Study
- Hemolysis – Rabbit Blood
- Sensitization
- Intramuscular Implantation – Subchronic (30 days)

These test results are based on single lots of the Momentive materials. Although a lot-to-lot variance would not be expected to show different test results, these data should not be construed as a warranty of fitness for use.
